General part of the EEC Final Report

In September 2015, the Corporate Fund "University Medical Center" (hereinafter referred to as CF "UMC") was created by the decision of the Board of Trustees of Nazarbayev University (Minutes No. 20 dated September 20, 2015).

Since 2016, the transformation process of the School of Medicine "Nazarbayev University" and CF "UMC" into an academic medical center began.

The goal of CF "UMC" is to provide safe, effective and high-quality medical care, to develop, implement and distribute modern technologies in the field of medical science, education and practice.

CF "UMC" has united five leading medical centers, including National Research Center for Maternal and Child Health (hereinafter referred to as NRCMCH), National Children's Rehabilitation Center (hereinafter referred to as NCRC), Republican Diagnostic Center (hereinafter referred to as the RDC), National Scientific Center for Oncology and Transplantology (hereinafter - NNTSOT) and Kyzylorda branch of the Corporate Fund "University Medical Center" (NRCMCH, RDC, NCRC) passed the international accreditation of the Joint Commission International.

In accordance with the Charter of CF "UMC", one of the main activities of CF "UMC" is educational.

Training in residency in the CF "UMC" is carried out since 2016. The total number of students in the 2017-2018 school years was 202 residents.

In 2018, 58 people graduated.

Educational services of CF "UMC" at the level of additional professional education. In 2016-2018, teachers of CF "UMC" trained more than 4,500 students in advanced training and retraining cycles from the regions. Within the framework of the 005 republican budget program, 340 specialists of health organizations of Kazakhstan were trained.

The total number of teachers involved in the educational process of residency and additional vocational training is 206 people, including 27, candidate of medical sciences - 60.

Analysis of the self-evaluation report of CF "UMC" for compliance with the Standards for Institutional Accreditation in Postgraduate Medical Education

The report on the institutional self-evaluation of CF "UMC" is presented on 149 pages, excluding annexes, is characterized by the completeness, structuredness and internal unity of information provided by the accredited educational organization about its activities. The report is accompanied by a cover letter signed by medical director Sandro Vento, confirming the accuracy of the information and data contained in the report.

The institutional self-assessment of the CF "UMC" was carried out on the basis of the order No. 18-n/c dated May 15, 2018 "On the approval of the composition of the working group on preparation for institutional accreditation of the corporate fund of the "University Medical Center".

The level and quality of self-evaluation of CF "UMC" activities

Based on the analysis of the self-evaluation report by experts, it was found that the content of the self-assessment report is structured in accordance with the Standards for Institutional Accreditation in Postgraduate Medical Education.

The report on the institutional self-assessment of the corporate fund "University Medical Center" is presented on 149 pages and contains 27 annexes on the relevant standards.

2. Analysis for compliance with institutional accreditation standards based on the results of an external assessment of CF "UMC"

 - availability of clinical bases accredited according to JCI international standards;
- CF "UMC" uses appropriate methods of teaching and learning, guarantees the integration of components in practice and theory, experience in assisting the patient, independent and active learning.
- CF "UMC" introduces scientific foundations and methodology of medical research, including clinical research and clinical epidemiology, into postgraduate

education programs, apply methods of critical evaluation of literature, articles and scientific data in teaching.

- compliance of the final competencies of the residency programs of CF "UMC"

- CF "UMC" has modern innovation centers, scientific and clinical bases that contribute to the intensification of educational and clinical processes, and conduct scientific research.
- In CF "UMC" methods of active vocational practical training are used, aimed at stimulating cognitive activity and motivation, developing decision-making skills, critical thinking, teamwork in real professional activity. CF "UMC" has high scientific and academic potential.
 - The share of the staffing level of the staffing capacity of the faculty is high.
- Wide access to international databases. Positive growth dynamics of all indicators of research.

The members of the EEC came to a unanimous opinion to recommend to the Accreditation Council to accredit the Corporate Foundation of the University Medical Center of Nazarbayev University for a period of 5 years.
