The work of the EEC was carried out in accordance with the Regulation on the EEC (Order of the ECAQA General Director No. 4 dated February 13, 2017).

The EEC report contains an assessment of the KGP "Kostanay Higher Medical College" of the Health Department of the Akimat of the Kostanay Region for compliance with the Standards of institutional accreditation of medical colleges (hereinafter - the Accreditation Standards), recommendations of the EEC for further improving the activities of the college.

**2. General part the final report of the EEC**

**2.1 Representation of the PSE "Kostanay Higher Medical College" of the Health Department of the Akimat of the Kostanay region**

Kostanay Medical College was opened in 1929 as an obstetric technical school, in 1996 the Kostanay Medical School received the status of a college.

In April 2018. The college received the status of a higher medical college (Resolution No. 307 dated June 29, 2018). The college carries out educational activities on the basis of state license No. KZ90LAA00012840 dated 09/12/2018 from the following specialties: 0301000 "General Medicine, qualifications 0301013 Paramedic", 03010123 "Midwife "; 0302000 "Nursing", qualifications 0302043 "Medical nurse of general practice", 0302054 "Applied bachelor of nursing"; 0304000 "Dentistry", qualifications 0304013 "Assistant to a dentist", 0304023 "Dentist"; 0305000 "Laboratory diagnostics", qualification 0305013 "Medical laboratory assistant"; 0306000 "Pharmacy", qualification 0306013 "Pharmacist". The department of advanced training and retraining of secondary medical and pharmaceutical workers has been operating since 1996.

The number of personnel trained for health care over 5 years is 11066, including those trained on

the budget - 669 people.

The college is located in a typical building, the total area of all premises used for the organization of the educational process is 3712 sq. M., Per one teacher is 4.3 sq. M.

The share of full-time teachers is 89%, the total number of full-time teachers is 78, part-time teachers - 9 people. All teachers have basic education. The share of teachers of the highest and first category, masters, PhD, candidates of science, from the number of teachers in the prepared qualifications of the specialty, for whom the main place of work is college - 61%.

The total number of students is 1442, of whom are enrolled: under the state educational order - 880, on a business contractual basis - 562.

In 2019, on the basis of the Rudny city hospital (Rudny), a branch "Nursing" No. 2 was opened, where 150 students' study.

## **2.2 Information on previous accreditation**

Institutional accreditation. Certificate for 5 years, (Registration number AA0033 dated 30.10.2015, Independent Agency for Accreditation and Rating (hereinafter-IAAR). Post-accreditation monitoring - October 2019.

## **2.3 Analysis of the self-assessment report of the PSE "Kostanay Higher Medical College" of the Health Department of the Akimat of the Kostanay region for compliance with the Standards of institutional accreditation of medical colleges**

The College Institutional Accreditation Report is presented in 130 pages of main text, 30 page annexes.

The report is characterized by the completeness of responses to all 9 accreditation standards, structuredness based on the recommendations of the ECAQA Self-Assessment Guidelines, and the internal consistency of information provided by the accredited college. The report is accompanied by an accompanying a letter signed by the director Ospanova Aigerim Kairovna, Ph.D., confirming the accuracy of the information and data contained in the report.

Institutional self-assessment of the KGP "Kostanay Higher Medical College" of the Health Department of the Akimat of the Kostanay region was carried out on the basis of order No. 50-P of 12.02.2020. "On the appointment of those responsible for the preparation of the self-assessment report within the framework of institutional and specialized accreditation."

## **3. Description of external expert commission and conclusions**

External expert work on institutional accreditation was organized in accordance with the Guidelines for conducting an external assessment of educational organizations and educational programs of ECAQA (approved by order of the Director General of the NU "Eurasian Center for Accreditation and Quality Assurance in Education and Healthcare" No. 15 dated 09/11/2020) and according to the program and schedule approved by 25 September 2020, Director General of ECAQA Sarsenbayeva S.S. and agreed with the director of the college Ospanova A.K.

External expert commission Compliance with ECAQA Accreditation Standards began on September 14, 2020, which included expert commission of self-assessment reports, preliminary examination of documents, examination of the college website.

To obtain objective information, the members of the EEC used the following methods: interviews with management and administrative staff, interviews with students, observation, study of the website, interviews of employees of various structural units, teachers, online questioning of teachers and students in the period 6-12.10.2020, review of resources in context compliance with the standards of institutional and specialized accreditation, the study of college documents and teaching materials for accredited 8 educational programs.

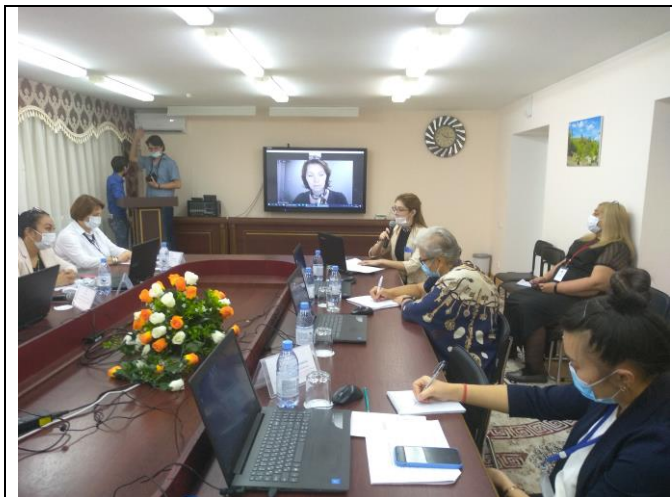

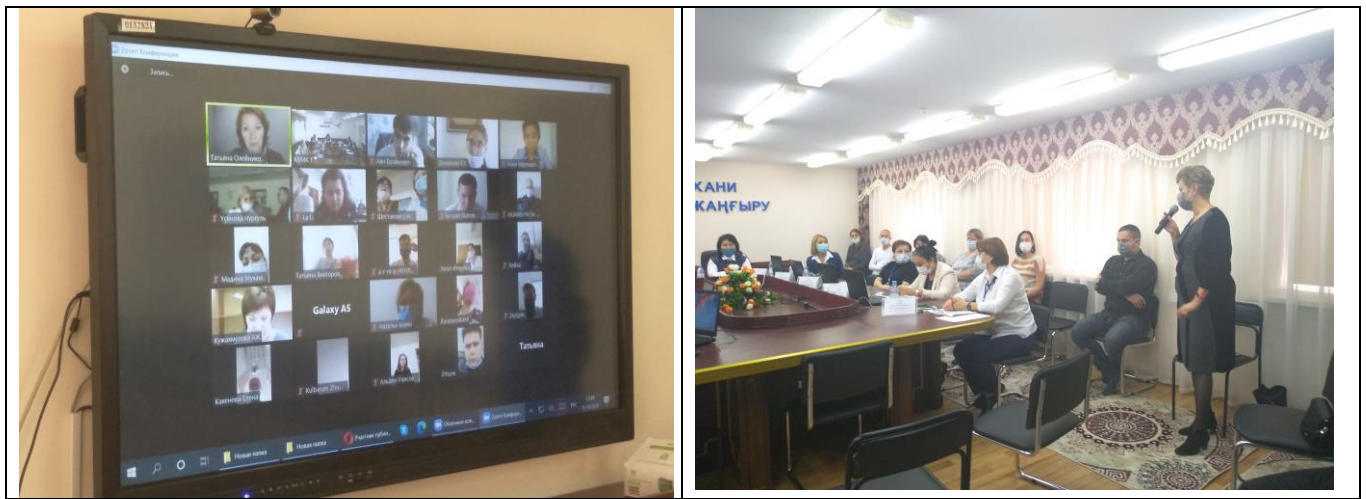

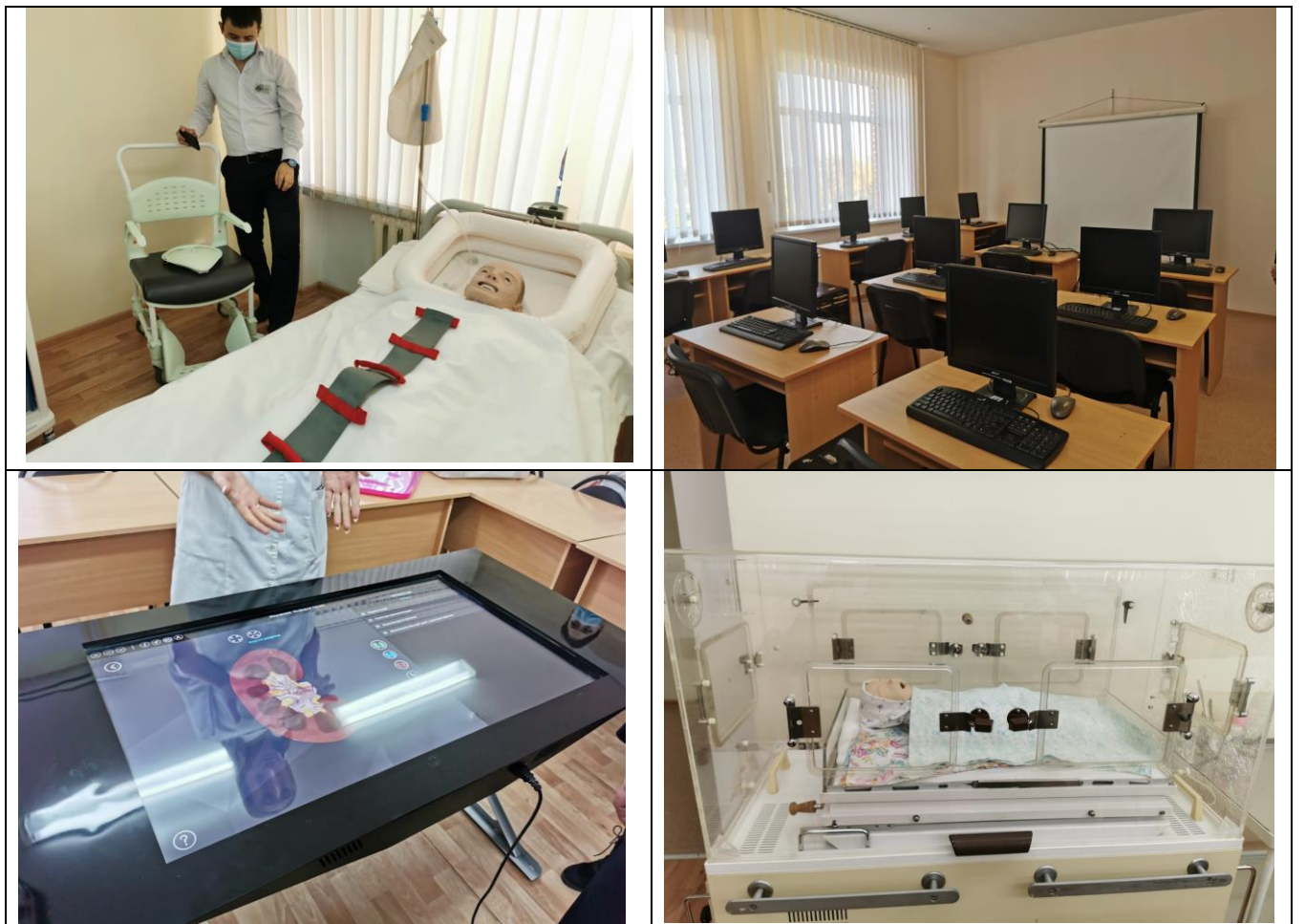

#### **4. Results of the survey**

The ECAQA observer conducted an online survey of college students on the resource <https://webanketa.com/> from 6-12.10.2020. In total, the proposed questionnaire contains 22 questions, including an assessment of satisfaction with training and resources of the organization. The total number of students to whom the questionnaire was sent is 1179. The total number of respondents is 604.

**Conclusion:** The external expert commission of ECAQA determined that the college has a corporate culture and ethical behavior between all participants in the educational process, as well as a

developed system of mentoring and consulting students on academic and personal issues. This leads to a positive attitude of students to the place of study. At that time, students are not fully involved in the work of advisory bodies on the development of the mission, discussion of the educational program and the educational process. Low involvement of students in research work was noted. Not all teachers provide feedback on the results of the lesson, and teaching methods need to be improved.

**An online survey of 78 teachers was conducted on October 6-12, 2020, the number of respondents was 58 (according to the staffing table - 78).**

**Findings:** the team has a corporate spirit and support from the management. The teachers are satisfied with the working conditions and the organization of the educational process, at the same time, it is necessary to complete special disciplines with qualified teachers, to strengthen the issues of advanced training in subjects and in the QMS.

**5. Analysis for compliance with the standards of institutional accreditation based on the results of external assessments by the PSE "Kostanay Higher Medical College" of the Health Department of the Akimat of the Kostanay Region and an overview of the strengths for each standard.**

### **Standard 1: MISSION AND OUTCOMES**

The expert commission received convincing data that the system management of the College corresponds to a quality management system aimed at achieving the mission, goals and objectives. Active international cooperation and a developed material and technical base, qualified teaching staff meet the high requirements in the field of education.

The team sets itself the task of further improving the educational process and improving the image of the nursing school.

#### **Strengths:**

- 1) The mission of the college complies with the national qualification framework, professional standards and the requirements of the State Educational Standard of the Ministry of Health of the Republic of Kazakhstan for medical and pharmaceutical specialties
- 2) Higher College status;
- 3) Recognition of merit college in the Republic and abroad in the educational field;
- 4) Trust of potential and real consumers of educational services;
- 5) Implementation of an applied bachelor's degree program in a college to meet the needs of the region with applied bachelors of nursing as part of the nursing reform in Kazakhstan;
- 6) Expansion and strengthening of international relations with large educational and scientific centers of the near and far abroad

#### **Recommendations for improvement identified during the external visit:**

- 1) Ensure stakeholder participation in the development of the college's mission and strategy.

### **Standard 2: EDUCATIONAL PROGRAMMES**

The content of educational programs in all specialties meets the requirements of the State Educational Standard and is implemented in accordance with the professional competencies of future mid-level specialists. The educational program corresponds to the competencies of future specialists. Preclinical training in practical skills is provided. Practical training is conducted at clinical sites and meets the qualification requirements of future specialists.

#### **Strengths:**

- 1) Availability of high-quality information and methodological support;
- 2) Highly qualified teaching staff, skillfully applying active methods and information technologies of teaching;
- 3) Availability of clinical sites.

#### **Recommendations for improvement identified during the external visit:**



- 1) To develop a Regulation on elective disciplines, which determines the order of their choice, conditions and procedure for organizing the educational process in elective disciplines;

- 3) Strengthen the formation of communicative competence, critical thinking and decision-making skills in students;

### **Standard 3: ASSESSMENT OF STUDENTS**

In general, the quality of graduate training meets the needs and expectations of modern society. The educational process of the College is aimed at student-centered learning. The college is continuously improving its educational activities, taking into account the requirements and wishes of both employers and students.

#### **Strengths:**

- 1) Sufficient material and technical equipment and creation of favorable conditions for quality education
- 2) Satisfaction of participants in educational activities with the quality of educational services
- 3) Students are assessed using sequential procedures based on uniform criteria and provisions. Satisfaction of participants in educational activities with the quality of educational services;
- 4) High percentage of progress when passing the final certification
- 5) Availability of innovative copyright materials with the assignment of an ISBN code and a stamp in the specialty.

#### ***Recommendations for improvement identified during the external visit:***

- 1) Develop a procedure for assessing the reliability and validity of the applied methods of monitoring students' knowledge;

### **Standard 4: STUDENTS**

Admission of citizens to the College is carried out on the basis of the RLA RK. The admission rules indicate the requirements for candidates and a list of required documents.

The selection process for students begins with the acceptance of applications from applicants, technical secretaries introduce applicants to the specifics of each specialty, who is faced with the choice of a particular qualification. Since 2019, entrance examinations are conducted in the automated system MyTest. The results of entrance examinations are posted on the day of the exam on the information stands and on the college website. Applicants have the right to submit an application to the appeal commission. All decisions are recorded. Responsible secretaries prepare summary sheets and provide members of the selection committee for a decision on the admission of applicants to the medical college students.

As part of the implementation of the activities of subproject 2 "Enhancing the role of nurses in the health care system" of the Roadmap of the Project "Modernization of Medical Education and Science" for 2016-2019, the College has been participating in the pilot implementation of a differentiated selection of applicants to medical colleges that implement educational programs since 2017. specialty "Nursing", in the form of an interview with a comprehensive and independent assessment of the non-cognitive abilities of applicants.

The college annually conducts psychometric testing, which allows you to check the suitability and ability of students to practice in secondary health care. This selection process excludes the recruitment of college students who are not ready to devote their lives to medicine. This method of selection helps to reduce student dropouts of their own free will.

The college administration pays special attention to the conditions of students from different social categories. The Regulation "On the Commission for the Consideration of Scholarships,

Discounts / Benefits for Tuition Fee” was developed. Students from socially vulnerable groups of the population are provided with material assistance for food and uniforms in accordance with the established norms of the Decree of the Government of the Republic of Kazakhstan No. According to the PPRK dated February 7, 2008. No. 116 scholarships are paid to students under the state order, 2 times a year - travel compensation.

Information about support services is communicated to students through a guidebook, syllabuses, the committee on youth affairs digest, AIS "Platonus".

For the purpose of professional direction of college graduates, an information stand "Tylektertaktasy" is located in the hall of the 1st floor. A memorandum of cooperation was concluded with the Karaganda State Medical University, the International Educational Holding GAUDEAMUS.

The involvement of students in the management system as part of the educational community is ensured by the student self-government body (the committee on youth affairs), which contributes to self-realization of students and the solution of issues in various areas of student life throughout the entire period of their study at the educational institution.

At meetings of the committee on youth affairs, self-government issues are discussed, considers all issues related to students of the faculty, participates in the development of proposals and recommendations on all issues with students, and also contributes to the formation of leadership qualities among students.

**Strengths:**

- 1) There is a system of student self-government, active work of the volunteer movement
- 2) Students who belong to a socially vulnerable category are provided with a preferential tuition discount of 80% and other types of social support
- 3) A center for psychological relief of communication skills has been created
- 4) Participation of students in republican and international competitions

**Standard 4: completed**

**Recommendations for improvement identified during the external visit:**

- 1) To increase the percentage of students' coverage of students' research work;
- 2) Ensure the formation of competencies in the preparation and conduct of scientific research by students;

**Standard 5: ACADEMIC STAFF / FACULTY**

The college implements personnel policy in accordance with the main priorities of the college development strategy for 2018 - 2023. The management of the college on an ongoing basis analyzes the quantitative and qualitative teaching staff, and also regularly monitors and evaluates teaching activities.

Highlighted the strategic goals that ensure the qualifications and competence of the teaching staff for the implementation of EP in all specialties in accordance with licenses.

Professional development of teachers is carried out in various training centers, in the Almaty State Institute for Advanced Training of Doctors of JSC "Kazakh Medical University of Continuing Education" / MUNO /, in LLP "International Institute of Post-Secondary Education" / IIEP / Astana, in the Republican Center for Health Development, Higher College of Astana, Karaganda State University "Center for the transfer of innovative technologies", etc.

During the pandemic, in May 2020. teachers took 36-hour distance courses of the Talap Educational and Training Center on the topics "Distance learning in organizations of technical and professional, post-secondary education: from content creation to the organization of the educational process" and "Organization of students' independent work in conditions of distance learning."

**Strengths:**

- 1) Availability of qualified staff of teachers, incl. with the education "Bachelor of Nursing"
- 2) Training of mentors in the College's own base
- 3) The system of rating assessment of the competence of the teaching staff
- 4) Professional development of teachers and college staff in regional, republican, international courses and seminars
- 5) The presence of simulation rooms and a dental laboratory for the development and formation of professional competencies on modern devices, simulators and phantoms;

**Standard 5: completed**

**Recommendations for improvement identified during the external visit:**

- 1) To intensify the publishing activities of teachers;
- 2) Continue staffing of qualified personnel in special disciplines (dentistry, medicine);
- 3) To include in the system of continuous professional development of college teachers, training courses aimed at developing the competencies of research work, as well as establishing and maintaining international scientific contacts;
- 4) Provide an increase qualification of teachers for at least 108 hours over 5 years in the relevant profile on the basis of order No. 391 of the Ministry of Education and Science of the Republic of Kazakhstan...

**Standard 6: EDUCATIONAL RESOURCES**

The main goal and principles of the College's mission is to provide students and trainees with a high level of knowledge, professionalism by preserving medical traditions and introducing innovative technologies.

Comfortable conditions have been created for the work of teachers and staff, for obtaining decent knowledge of students. Students and teachers of the College are provided with the necessary material and technical base, modern information and educational resources. Educational and material base of the educational process meets the requirements of training specialists and ensures the implementation of curricula and programs...

Requirements for the material and technical support of educational services are determined by the list of equipment for classrooms and laboratories according to the state educational standard.

To organize high-quality work with document flow, the college is provided with more than 40 devices for printing, of which 3 color printing, 10 scanners.

Free local network software is used to send messages and files. Information and communication technologies are used effectively. Provided access to the Internet 48 Mb / s, Wi-Fi coverage. 14 classrooms are provided with interactive boards. The conference room has a 65-diagonal wall-mounted touchscreen monoblock with Internet access

The stable financial position of the college allows annually to allocate significant funds to strengthen the material and technical base. In the 2019-2020 academic year, a rehabilitation and ergonomics center were opened for the educational process, the library fund was replenished (45,596 copies) in the amount of 21.9 million tenge; dummies and phantoms were purchased for the amount of 1.5 million tenge.

**Strengths:**

- 1) Availability of an electronic library system
- 2) We have our own center for rehabilitation and ergonomics
- 3) Availability and constant replenishment of the fleet of modern simulation mannequins, computer and interactive equipment
- 4) Training of teachers at advanced courses, seminars and conferences in partner Russian universities and colleges
- 5) Wide coverage of clinical sites for internship
- 6) The international cooperation
- 7) Existence of a system of international student exchange between medical colleges

**Standard 6: completed**

**Recommendations for improvement identified during the external visit:**

- 1) Renew the library fund for the specialty dentistry;
- 2) Improvement of MTB (gym, dormitory);
- 3) To activate the work of the AIS "Platonus", to fill in the data of teachers and students, library data, methodological materials by discipline.
- 4) Develop and implement a policy of international cooperation aimed at improving the planning and implementation of international activities in priority areas;

## **Standard 7: PROGRAMMES EVALUATION**

An analysis of the intermediate, final state certification shows that the achievements of students are consistent with the expected learning outcomes. According to the results of the survey, a fairly high level of student satisfaction with the educational process, the conditions of training in college is shown. Social partnership, the expansion of interaction between the college and healthcare organizations, which contribute to improving the quality of training of specialists and the provision of medical care, provides for improving the quality of training specialists in the educational program. The college has sufficient experience in the participation of employers and other social partners in solving the problems of vocational education, interaction with medical organizations, which makes it possible to train qualified specialists.

### **Strengths:**

- 1) Qualified teaching staff
- 2) Active involvement of employers of practical healthcare in the educational process
- 3) Expansion of partnership in the implementation of programs, participation in international academic mobility programs
- 4) Effective interaction with social partners in the preparation of educational programs, professional practice programs, in the assessment of knowledge, abilities and skills of students; the use of an effective system for assessing the practical knowledge and skills of students during final certification (ASTOP, OSKE);
- 5) High percentage of satisfaction of teachers, employees, students, employers with the conditions of work organization in the college
- 6) High employment rate of graduates

### ***Recommendations for improvement identified during the external visit:***

- 1) Determine priority areas of research in the context of ongoing educational programs;

## **Standard 8: GOVERNANCE AND ADMINISTRATION**

The college is actively working on the exchange of information, cooperation with social partners and public organizations, the media (periodicals, television, Internet). For the availability of information about the activities of the college, about the educational services provided to interested parties, the college has created a website [www.komeco.kz](http://www.komeco.kz). in three languages (state, Russian in English), commercials in social networks, booklets for applicants, feedback for all categories of interested parties.

To determine the needs of the actually possible volume of financial resources and their use, a budget application is drawn up for the forecast period. Cost planning for the implementation of the educational process is based on indicators such as the size of the contingent and the teaching staff. In 2020. In connection with the increase in the state order and the opening of the Nursing Department in the Rudny city hospital, budget funds were allocated for the educational process under the program 253-034-015 "Capital expenditures of state educational organizations of the health care system" in the amount of 69,000.0 thousand tenge...

### **Strengths:**

- 1) Management systems and operations are open, transparent and accessible;
- 2) The college has a certified QMS.
- 3) The number of students enrolled in the state educational order has been increased;
- 4) Opening of the department "Nursing" in the Rudny city hospital.

### ***Recommendations for improvement identified during the external visit:***

- 1) Bring the educational planning, educational and methodological in accordance with the requirements of the Quality Standards ISO 9001: 2015;
- 2) Create a structural unit for the quality management system;
- 3) To develop indicators for the relevant indicators of college departments to improve the quality of educational and educational processes and identify strengths and weaknesses;

### **Standard 9: CONTINUOUS RENEWAL**

MSE "Kostanay Higher Medical College" is one of the leading educational institutions of TVE. It should be noted that there is a fairly widespread use of various sources of funding in terms of ensuring the success of the college's financial activities: the local budget, the republican budget and the college's own funds. Significant funds are allocated for the reconstruction and repair of the classroom fund, the general aesthetic improvement of the environment in the educational building. Improving the conditions for the use of various new technologies in education, in addition to repairs, is also associated with further development and financial costs for the material and technical support of the educational process.

Strengths:

- 1) The development strategy of the college has been developed, aimed at training competitive specialists focused on work in multidisciplinary medical organizations capable of operating in market conditions.
- 2) Plan for early 2021 is expected to operate a student dormitory for 250 places
- 3) The plan for 2021 is to receive an annex to the license to carry out training in the specialty "Hygiene and Epidemiology". Admission in 2021-2022 on the state educational order is expected to be 500 people.

*Standard 9: completed*

*Recommendations for improvement identified during the external visit:*

- 1) Create a repository in the library to store educational and teaching materials, graduate diplomas and provide access to responsible persons.

Thus, all 9 accreditation standards have been met, no inconsistencies in the fulfillment of the criteria of each of the basic accreditation standards in the process of analyzing the self-assessment report and conducting the examination as part of the tasks of the external expert commission program were found.




