

#### 2. General part of the final report of the EEC

2.1 Representation of the PSE on REM "Pavlodar Higher Medical College" and the educational programme in the specialty 0307000 "Orthopedic dentistry" qualification 0307013 "Dental technician"

The history of Pavlodar Higher Medical College begins in 1949 with the opening of a 2-year nursing school.

By the decree of the Council of Ministers of the Kazakh SSR No. 707-r of 04.08.1954, the medical school was reorganized into a medical school, where they began to train not only nurses, but also paramedics and midwives.

The school received the status of a college in 1995.

In 2012, the college implemented a quality management system for compliance with the requirements of ST RK ISO 9001-2009 (certificate No. KZ.7100759.07.03.00072 from 20.06.2012 to 20.06.2015)

Since March 2013, the continuing education department has been reorganized into the Center for Continuing Education for Secondary Medical and Pharmaceutical Workers. Over the years, more than 25 thousand middle-level medical workers have improved their qualifications.

In the 2014-2015 academic year, within the framework of the implementation of the World Bank Project "Technology Transfer and Institutional Reform in the Health care Sector of the Republic of Kazakhstan", an educational programme of applied bachelor's degree in the specialty "Nursing" was introduced in an experiment mode.

In 2014, on the basis of the order of the Ministry of Health of the Republic of Kazakhstan, the Regional Simulation Center was opened.

In 2015, an international quality management system was introduced for compliance with the requirements of ISO 9001: 2008 (TUVRheinlandCertGmbH quality certificate No. 011001518810 from 03.07.2015 to 02.07.2018).

In 2016, the college received the status of a higher college.

On the basis of the order of the State Institution "Finance Department of Pavlodar region" dated July 9, 2017 No. 336 "On communal property", non-residential premises of the administrative building of medical organizations, located on I. Bayzakov street, 151/2, were transferred to the economic management (balance) of the medical college with a total area of 4196.0 square meters, where a dormitory is currently planned for college students and young professionals in practical health care. Work has begun on design and estimate documentation. Commissioning is planned for 2022. The total area of the two buildings is 10741.1 sq. M., Of which the training area is 6837.8 sq. m. There are 7.7 square meters per student, which corresponds to the current sanitary standards. To conduct training sessions, 38 classrooms and laboratories are equipped, provided for by the State Educational Standard of the Republic of Kazakhstan in 2016 and 2020 incl.

There is an assembly hall with an area of 250.8 square meters, a library with a reading room for 30 seats, a sports hall with an area of 267.9 square meters, a professional football field, a dining room for 200 seats. The total library fund as of October 1, 2020 totals 55905 publications (including 10630 in the state language).

The fund of educational literature from the total fund is 28300 copies (including 6689 copies in the state language). The fund of educational and methodical literature consists of 23111 copies. Of these, 5457 copies of methodological literature (including 967 copies in the state language), scientific literature - 13587 storage units (including 2137 publications in the state language), reference, official and other literature - 4067 copies. The fund of fiction and periodicals comprises 3897 items (including 358 in the state language). The fund of the media library consists of 2,615 electronic publications (including 359 in the state language), of which 597 are licensed publications (143 in the state language).

The college has structural units that are responsible for certain areas of the educational process. The responsibility of each structural unit and employees is established in the regulations on structural units and job descriptions.

The general management of the college is carried out by the director - Kasimova Bakyt Kabidulovna. Educational part - Deputy Director for teaching and educational work-**Baygulzhina Zhazira Zabirovna**, supervises the work of the units that organize the educational and scientific - methodological process in the college. The deputy director for teaching and educational work provides guidance on all issues of organization of the educational process and oversees the work of the educational department. Educational, research, clinical, educational work is provided by teachers and staff.

Deputy Director for Industrial and Practical Training **Dyusembaeva Zhanargul Begaidarovna** carries out management of clinical practice from the college and educational and methodological support of industrial and professional practice of students.

The highest collegial governing body of the college is the Pedagogical Council. The PC works according to the plan approved by the director of the college, meetings are held once every 2 months, the PC minutes are kept in the state and Russian languages. The PC includes representatives from the Ministry of Defense and students.

Self-assessment of the PSE on REM "Pavlodar Higher Medical College" of the Health Department of the Akimat of the Pavlodar region was carried out on the basis of order No. 196 -P dated 01.09.2020 "On the appointment of those responsible for the preparation of a self-report on institutional and specialized accreditation." on self-assessment and preparation for accreditationeducational programme for specialty 0307000 - "Orthopedic dentistry" qualification 0307013 - "Dental technician" "The report is characterized by the completeness of answers to all 9 accreditation standards, structuredness, taking into account the recommendations of the ECAQA Self-Assessment Guidelines, as well as the internal unity of information provided by the accredited college.

The college staff responsible for the self-assessment and preparation of the Report carried out significant work on processing and systematizing the material, highlighted the college's achievements in the main areas of activity. The working group on the preparation of the self-assessment report has done a certain amount of work: the key areas of institutional activity, tasks for the implementation of 5 specialties have been analyzed, the necessary information has been collected in accordance with the accreditation standards; a thorough analysis, updating and addition of methodological and educational materials was carried out, their content is reflected in the report. There are links to regulations, model rules, regulations, teaching documents, website pages http://www.

Over the years of its existence, the college has trained mid-level medical workers in the specialty "Orthopedic Dentistry", including 355 dentists, 37 dental assistants, 255 dentists. At the moment, 42-1 year students and 23 graduate students are studying at the "Orthopedic Dentistry" department of the "Dental technician" qualification. For this specialty, the form of training is daytime. Normative term of study: 1 year 10 months on the basis of general secondary education. The language of instruction is Russian.

To ensure high-quality training of specialists for the qualification "Dental Technician", the leadership of the medical college is forming the teaching staff, organizing educational and methodological work, equipping classrooms and laboratories. The educational curriculum for the specialty "Orthopedic Dentistry" is based on the State Educational Standard of Education 2019. 19 teachers take part in the training of specialists in the educational programme "Orthopedic Dentistry": the qualitative composition is 40.4%. All teachers have an appropriate basic education corresponding to the discipline taught.

Thus, the self-assessment report of the educational programme for compliance with the ECAQA specialized accreditation standards in the specialty 0307000 - "Orthopedic dentistry" qualification 0307013 - "Dental technician" "of the college contains objective, detailed, structured information on all types of activities.

The content of the Self-Assessment Report is structured in accordance with the ECAQA Accreditation Standards and includes a description of the strengths, areas for improvement for each of the 9 standards. Description of the key activities of the college fairly complete and updated software the number of students, teachers, administration, information on selection and admission, learning outcomes, knowledge and skills assessment results, material and technical base, contractual obligations with partners, financial information, plans for development and improvement, etc.

Conclusion on each of the 9 accreditation standards includes a description of strengths and areas for improvement.

The report is written in a competent language, the wording for each standard is clear and understandable, the tables contain references in the text and are consecutively numbered.

#### 3. External expert evaluation

#### 3.1 Description of the visit of the external expert committee

The work of the external expert commission of the Eurasian Center for Accreditation and Quality Assurance in Higher Education and Health Care within the framework of institutional and specialized accreditation of the PSE on the REM "Pavlodar Higher Medical College" of the Health Department and the Akimat of Pavlodar region on the assessment of the college was organized in accordance with the Guidelines for the external evaluation of educational organizations and educational programmes of ECAQA (approved by the order of the Director General of the NJSC "Eurasian Center for Accreditation and Quality Assurance in Higher Education and Health Care" No. 5 dated February 17, 2017) and according to the programme of the external visit, approved on May 11, 2021 by the Director General of ECAQA Sarsenbayeva S. and agreed with the director of the college Kasimova B.K.

To obtain objective information, according to an expert assessment, the members of the EEC used the following methods: interviews with management and administrative staff, observation, study of the website, interviews with students, alumni, interviewing employees of various structural units, teachers, questioning teachers and students, a review of resources in the context of the implementation of accreditation standards, the study of educational and methodological documents.

On the part of the college staff, the presence of all persons indicated in the visit programme and according to the lists of interview sites is ensured (Attachment 1).

#### The first day of the visit is 05/26/2021.

The first day of the EEC began with a visit to the college and getting to know the management. Director **Kasimova Bakyt Kabidulovna** has been running the college for only 3 months, so the former director, Sitkazinova Gulnara Kinzhitaevna, was also invited to the meeting. Bakyt Kabidulovna introduced us to the mission of the college and the strategic development plan.

At the meeting with the management of the college, an overview presentation of the college was presented. Further, an interview with the leadership took place on the mission, strategic development of the organization as a whole and educational direction.



At 9.45, EEC with the academic leadership discussed the management of educational programmes, career guidance, student recruitment, monitoring of employment. From 10.15 to 11.15 interview with the management of the college departments and the heads of the educational advisory center. We discussed the development, approval and implementation of software with the managers, control and measuring tools for assessing the knowledge, skills and abilities of students, analysis of software effectiveness. Interview on educational and social work with students. At 11.15. the responsible staff gave a tour of the college. EEC members visited the simulation center, medical office, gym and assembly hall, college library and got acquainted with the library fund. Demonstration of practical skills with students using simulation equipment, mannequins, phantoms in training programmes in the specialty:

At 14.15 an interview with college teachers took place. The issues of EP and its implementation, the introduction of innovative teaching methods was discussed. The teachers talked about differentiated wages and its criteria, material assistance from the trade union committee. We discussed pedagogy and monitoring the quality of student learning.

At 14.55, EEC members were presented with a Presentation on educational work and interview on educational and social work with students, support and counseling of students on personal issues; formation and development of communication skills, leadership; activity; projects; volunteer movement; feedback from students, prevention and correction of behavioral changes in students, psychological support of students during the educational process.

At an interview with students of educational programmes at 3.35 pm, they discussed issues of choosing electives, retaking exams, the possibility of applying if they do not agree with the assessment. The students were very active and open in communication.

At 16.05 Demonstration of college website, e-resources of educational programmes, distance learning platform, e-zine.

From 16.35 to 17.45 we studied the documentation on educational programmes of the college, including at the request of members of the EEC.

After that, the EEC members held a meeting on the first day of the visit. Summed up the results of the external assessment, discussed the results of standards validation and data verification of the EP self-assessment reports. The day passed calmly, without stress, without deviations from the schedule, thanks to the well-coordinated work of the college staff.

#### Second day of visit May 27, 2021

The second day of work of the EEC began with a visit to the clinical bases of the college. We visited Medeo LLP and Azhar LLP, on the basis of which there are training rooms equipped with educational material. Interviewed with clinical practice management of students and college alumni working in these dental clinics.



We visited the Olimp laboratory at the base where laboratory students undergo practical training. At the Pharmacom pharmacy, the head shared the problem of lack of pharmacists and noted the high training of specialists who are ready to start working immediately after graduating from college. An interview with student activists took place from 12.00 to 12.30. The students acquainted the EEC members with the functions, duties and rights of the student council.



At 13.30 Nurakhmetova A.O. acquainted with the organization and content of the methodological service in the college.

- Scientific research work
- The international cooperation

At 14.00 Interview with the head of the department of applied bachelor's degree. We discussed questions about the preparation of the Diploma work of students of the applied bachelor's programme and the difficulties of writing it.

At 14.30, the EEC members were presented with the teaching methods used by teachers in the implementation of educational programmes "Orthopedic Dentistry", "Pharmacy", "Nursing", "General Medicine"

From 16.30 to 17.00, an interview with college graduates and an interview with employers-representatives of practical health care were held online on the ZOOM platform, the issues of employment of graduates and the degree of satisfaction with students' knowledge were discussed.

From 17.00 to 18.00 the commission left to study the documents and summarize the results of the second day of accreditation.

At 10.45, the Presentation of the Center for Continuing Education and Simulation Training was presented. Responsible: Rogovskaya N.V.

From 11.00 to 13.00 Study of the documentation on the educational programmes of the college, including at the request of the members of the EEC (survey results, employers' feedback, documentation of the pedagogical council and other advisory bodies) and designing the EEC report: developing recommendations for the college.

From 14.00 to 15.00 Final discussion of the results of the external assessment of college educational programmes for compliance with accreditation standards:

- Filling out individually by each member of the EEC a quality profile and criteria for external evaluation of educational programmes for compliance with ECAQA accreditation standards;

- Discussion of recommendations for the college; Final vote on the recommendations for the college;
- Final vote on recommendations for the ECAQA Accreditation Council

At 15.00, the chairperson and members of the EEC announced recommendations based on the results of an external assessment as part of the college's accreditation for 10 educational programmes for the management and staff of the college.

The programme and schedule of the external expert evaluation of the EEC has been completed in full. On the part of the college staff, the participation of all persons indicated in the programme is ensured.

#### 3.2 Results of the survey of key stakeholders

An observer from ECAQA in the period from May 26 to May 28, 2021 conducted an online survey of college students and teachers. on the resource <a href="https://webanketa.com/">https://webanketa.com/</a>...

#### **Student survey results:**

The survey was conducted in Russian, 395 students answered. In total, the proposed questionnaire contains 39 questions, including an assessment of satisfaction with training and resources of the organization. Students of the specialty "Nursing" (Nurse of general practice) -124 and "Nursing" (applied bachelor's degree) - 102 students took a more active part in the survey. Only -13 students took part in the specialty "Dentistry", 23 students - "Orthopedic Dentistry".

Almost 85% (332) will recommend studying in this educational organization to their acquaintances, friends, relatives, because "Programme managers and teachers are aware of the problems of students associated with studying in college" 86.8% (326) fully agree with this statement, 11.7% (56) partially agree and only 1% (9). doubt the answer or disagree.

To the question "Programme managers and teachers involve students in the work of advisory bodies (methodological council, pedagogical council, committees of educational programmes)" - yes, constantly - 64.47% (266), no, they DO not involve - 12.18% (40), I do not know anything about this - 11.68% (46) and doubt the answer - 6.09% (27) of the student.

87.82 (334) students are fully satisfied with the conditions and equipment of classrooms, college classrooms, partly 11.17% (48) and only 0.51% (3) are not satisfied. What says about a good MTB college- 87.82 (331) believe that the college has created conditions for students to rest and eat (rest rooms, benches / gazebos on the territory, buffet-dining room) in between classes, 6.6 (30) partially agree with this statement, and 3.55% (20) disagree partially or completely.

"Office equipment (computers, laptops, printers) are available for students in classrooms and practice bases" - 93.4% (354) fully agree with this statement, partially agree - 5.08% (29), the remaining 0.51% (4) partially disagree or find it difficult to answer.

To the question "Teachers provide students with methodological and didactic materials, additional literature to prepare for classes," 94.92% (364) fully agree, 4.57% (26) partially agree, and there are no students who partially or completely disagree. This indicates a high organization of the educational process.

"The organization of education has access to the participation of students in research work" - 83.25% (323) fully agree with this statement, 11.68% (45) partially agree with this statement, partially or completely disagree, only 0.51% (3). Also, students are satisfied with the library fund - 90.36% (345), partially satisfied 9.14% (40). The college has established access to electronic educational resources, and 92.89% (349) agree with this completely, are partially satisfied5.59% (33) and found it difficult to answer this question in total 1.52% (7) student.

Satisfied with the availability of health care services for a college student 86.29% (334). partially satisfied11.68% (43) and only 0% (3) are partially dissatisfied.

The subjective opinions of students about the quality of teaching in college were given by the following results: this is how they expressed their complete satisfaction with the activities of mentors, curators, tutors- 93.91% (358), partially satisfied - 6.09% (30), and not satisfied - 0% (2). It can be concluded that the level of performance of duties among tutors is at a high level.

So 98.48% (376) believe that college teachers and staff are respectful of students, disagree with this statement of all 1.51% (10).

"In the organization of education there are and are being implemented social programmes to support students" - agree - 90.86% (347), but there are 7.11% (33). have not heard of such a programme.

Aware that the college has a student career counseling service84.26% (323), and 9.64% (48) have not heard of such a service. We fully agree that the college has established a system of self-study for students / students -79.19% (322) agreed in part- 10.15% (39), and total 2.54% (10) partially disagree.

Students are satisfied with the organization of training at the practice bases, since 75.63% (287) consider such an organization to be excellent, 19.8% (90) rated as good, 1.52% (6) considered it satisfactory or doubted the answer.

During practical training at the bases, students have sufficient time for practical training (patient management and care, nursing rounds, work in laboratories, etc.), because 84.26% (328) agree with this completely, and in total 10.66% (42) partially agreed. We can note the good organization of practical classes in the college.

To the question "I am satisfied with the schedule of training sessions in the disciplines of the educational programme" - fully agreed 88.32% (349), and 9.64% (38) partially agree, but also 0.51% (3) is not happy with the schedule.

Almost all students, and this 90.36% (345) are satisfied with the methods of assessing knowledge and skills, but 8.12% (42) are partially satisfied.

Basically, students are satisfied with the content of the educational programme (list of disciplines) in the chosen specialty 88.83% (339) met expectations, 9.14% (50) partially agreed and 0% (3) strongly disagree. "Teachers use active and interactive teaching methods in the classroom" - believe that regularly88.32% (338), but there are those who believe that these methods are sometimes used 10.15% (44) or DO not know what it is-0.51% (5)

To the question - "How often the teacher is late for the start of classes" - 91.88% (353) believe that this was not the case and 7.61% (34) answered - sometimes.

"After the end of the class, does the teacher give you feedback (listens to your opinion, conducts a miniquestionnaire, work on mistakes)?" 83.76% (326), considered that sometimes- 13.71% (55), and 1.02% (9) believe that teachers rarely or never DO this. Students believe that the teacher (mentor, curator) of the college is an example for me as a professional doctor, a person (ethics, communication, appearance, speech), because 91.37% (348) fully agreed with this. Not all teachers of this educational organization are examples of 5.58% (24) students.

"There is a sufficient number of patients to carry out practical activities in the chosen specialty" -77.66% (306) completely satisfied, partially satisfied- 10.66% (44), which again speaks of a good organization of practical training.

Basically, all students are very happy with their studies in college, because the question "I like studying at this college" - fully agree with this statement - 91.88% (353) and only 6.6% (30) partially agree.

Relationships with fellow students, colleagues, medical personnel are completely satisfied - 95.43% (374) students, and 3.55% (17) are partially satisfied. To the question "Have you personally experienced a negative attitude from teachers?" answered no - 91.88% (354), sometimes, deservedly - 3.55% (18), and 0.51% (8) believe that yes, it is unfair.

"Are you happy that you are studying at this particular college?" completely satisfied - 89.85% (345) but there are also some - 9.14% (39).

The degree of student satisfaction with the work and the availability of the college leadership for students was: quite affordable 98.48% (387) and 1.52% (8) believe that it is not available.

92.89% (360) students are confident that the college allows them to acquire the necessary knowledge and skills in the chosen specialty. The remaining 0.51% (7) are not confident in their knowledge, which indicates a strong teaching school. Fully satisfied with the organization of teaching in the college 94.92% (368), and 4.06% (22) partially.

Also, the questionnaire involved questions about the work of the External Expert Commission on College Accreditation., For which 87.31% (337) answered positively and 8.12% (39) satisfactory.

84.77% (311) considered that it was necessary to conduct accreditation of college or educational programmes, 3.05% (19) DO not know what it is or doubted the answer. To the question "Have managers and / or teachers involved you in preparations for institutional or specialized (programme) accreditation?" the following answers were sounded: yes, when preparing a self-assessment report - 32.99% (61). Yes, for organizing a meeting of external experts - 7.11% (21). Yes, at all stages of preparation - 7.61% (25), I refused to participate (for a good reason) - 6.6% (19), I first heard about accreditation when the commission arrived or were not involved - 5.08% (24).

83.25% (333) considered that all the questions in the questionnaire were understandable and only 8.12% (35) understood the questions in part, which, by sociological standards, is quite enough to analyze the data obtained.

**Conclusions:** The most acceptable method of studying the opinions of students regarding the quality of educational services provided and organizational issues is a questionnaire, which makes it possible to more effectively solve the issues of monitoring and assessing the quality of the work of college teachers. In terms of the quality of the knowledge gained in the specialty: almost all students are satisfied with the quality of the knowledge they receive. Also, if you look at the answers to the questions asked earlier, you can see a good picture of mentoring, research and the use of interactive methods.

#### **Teacher survey results:**

A questionnaire was also conducted among teachers, 38 teachers took part in it. The questionnaire consisted of 26 questions, which considered all aspects of the teaching staff work. From the questionnaire, we found out that the teaching staff is quite stable and has extensive experience in this organization, since the work experience is more than 10 years.71.05% (27), from 5 years to 10-18.42% (7) and up to 5 years 10.53% (4).

When asked about the teaching of which disciplines, 63.16% (24) found out that most of the teachers are nursing, and 50% (19), the rest of the percentage fell on other disciplines.

"I am satisfied with the organization of the educational process in this educational institution" - 97.37% (37) - fully agree, and only 2.63% (1) partially disagree.

"In this educational organization, ethics and subordination are observed in relations between colleagues, teachers, management" - 97.37% (37) completely agree, and 2.63% (1) partially agree, and there are no teachers who disagree. This speaks of the high culture of the teaching staff.

"I am satisfied with the organization of labor and workplace in this educational organization" - 97.37% (37) fully agree, and only 2.63% (1) partially agree.

"There is an opportunity in the organization for career growth and development of teacher's competencies" -89.47% (34) fully agree and only 7.89% (3) partially agree.

"In this educational organization I have the opportunity to engage in scientific work and publish the results of research" - 89.47% (34) of the teacher answered positively, and only 7.89% (3) partially agreed.

On the question "I am satisfied with the salary" - 71.05% (27) are satisfied, and 18.42% (7) of the teachers answered who partially or YES more than NO.

"I am satisfied with the work of the HR (personnel) service" - 94.74% (36) are completely satisfied and only 5.26% (2) are partially satisfied.

"I studied at professional development courses (programmes)" - 36.84% (14) for less than 1 year, 44.74% (17) during this year, 18.42% (7) for more than 3 years.

"Characteristics of the microclimate in the team of the department / department / department / department where I work" - 63.16% (24) are completely satisfied, 34.21% (13) are quite satisfied and only 2.63% (1) DO not pay to it attention.

"In this educational organization I have the opportunity to realize myself as a professional in my specialty" -92.11% (35) fully agree, 5.26% (2) partially agreed and 2.63% (1) doubted the answer.

To the question "I believe that the students of this educational organization have a high level of knowledge and practical skills after completing the training programme" 89.47% (34) completely agree and only 7.89% (3) partially agree.

"Evaluate the timeliness of the execution of applications for the acquisition of methodological and didactic materials, office equipment, stationery to ensure the educational process in the organization" - 100% (38) is completed on time.

"The educational organization supports my participation in conferences (international, republican)" - 81.58% (31) - paying for travel, travel expenses, registration fees, and 13.16% (5) DO not apply to the management about this, 6 teachers left the question unanswered.

"Students have free access to patients at clinical sites and all the conditions for improving their practical skills" - 86.84% (33) - fully agree, 7.89% (3) partially agree and 2.63% (1) doubted the answer.

"During classes with students, I must have the following materials" -18.42% (7) have cases, 94.74% (36) have a Syllabus and an educational-methodological complex of the discipline, 89.47% (34) - control and measuring equipment (tests, situational tasks), 7.89% (3) - monographs, 94.74% (36) - educational logbook, 21.05% (8) - mining logbook, 52.63% (20) have lists of students, 63.16% (24) use an interactive whiteboard, 31.58% (12) use simulators.

"As a teacher of a special discipline, the theoretical part of the lesson takes  $\_$ % of the total amount of time" - up to 30% - 60.53% (23), up to 50% - 13.16% (5), almost 70% -13.16% (5) and 13.16% (5) of the teacher left the question unanswered.

"Are you satisfied with the level of prior training of students (residents) upon admission to training programmes in your educational organization?" - 47.37% (18) are fully satisfied and 47.37% (18) are partially satisfied.

"Do you do the work of a mentor, curator or tutor of students?" - are mentors of the resident - 2.63% (1), curators are 65.79% (25) teachers, 7.89% (3) - yes I am a tutor and 21 .05% (8) are not mentors.

"Is it difficult for you to combine teaching activity with clinical (practical) work in another organization?" - 34.21% (13) have a well-organized work organization, teaching activity prevails in 10.53% (4), 7.89% (3) these activities complement each other and I do not do clinical work - 50% (19) of teachers.

"Are social support programmes for teachers implemented in the educational organization?" - 89.47% (34) - yes, they exist, 2.63% (1) already use this programme, 2.63% (1) DO not know about such a programme.

"Do the heads of the organization listen to your opinion regarding issues related to the educational process, educational work, research and development, clinical work?" 78.95% (30) agree completely, 15.79% (6) think that sometimes.

"How do you assess your professional level?" - 76.32% (29) - high, 21.05% (8) average and 2.63% (1) found it difficult to answer.

To the question "What teaching methods do you most often use in the process of teaching students?" most of all teachers work in small groups - 78.95% (30), 63.16% (24) solving tests, 68.42% (26) analysis of situational problems, 71.05% (27) interactive learning, and only 39, 47% (15) use an oral survey of students.

"You think that this survey is useful for developing recommendations for improving the key areas of activity of your organization" - 94.74% (36) fully agreed and 5.26% (2) partially agree.

**Conclusions:** After reviewing all the comments and wishes of the interviewed teachers, we can conclude that almost everyone has a positive attitude to the educational processes taking place in the college, and wish the college further prosperity.

#### 3.3 Conclusions from external expert evaluation

As part of an external expert evaluation of the college for compliance with ECAQA Accreditation Standards by members EECs are carefully studied and evaluated main indicators of the organization.

The information obtained by external experts during the study of the self-assessment report, preparation of a written review with recommendations for improvement, interviews with management, employees of departments, study of documentation, during interviews with 17 administrative employees, interviews with 30 students, 25 teachers, 19 employers, and questioning 395 students, 38 teachers. All information received was compared with the data of the self-assessment report, which made it possible to make sure that the information provided by the college and supporting documents for compliance with the above-mentioned ECAQA Accreditation Standards was valid and validated.

During the external expert evaluation, the members of the EEC studied 75 documents (Attachment 2) and videos on learning resources, which made it possible to identify the conformity of the activity college accreditation standards...

Recommendations for improving the activities of the college for compliance with the Accreditation Standards, developed by the EEC based on the results of the expert evaluation, were presented at a meeting with the management on May 28, 2021.

Thus, the external assessment and the visit of the EEC members made it possible to verify and validate the data of the college institutional self-assessment report in full.

For the work of EEC, comfortable conditions were created, access to all necessary information and material resources was organized. The commission notes the high level of corporate culture of the college, the high degree of openness of the team in providing information to members of the EEC.

# 4. Analysis for compliance with the accreditation standards of the educational programme in the specialty 0307000 "Orthopedic dentistry" qualification 0307013 "Dental technician" and an overview of the strengths for each standard

#### **Standard 1: MISSION AND END OUTCOMES**

External experts have obtained evidence that the mission of the college is in line with the objectives of the country's development, the national technical and vocational education system, the health care system and the development of human resources. During interviews with students and teachers, interviews with leaders and employers, the participation of the team and the student community in the discussion of the mission and goals was established. The development and approval of the mission and vision took place in accordance with the existing procedure, ensuring the involvement of all stakeholders, both at the planning stage and in the implementation of decisions. Student-centered and practice-oriented training of future specialists with secondary specialized education ensures the implementation of the final learning outcomes, the list of which is included in the working curricula. Students in the specialty "Orthopedic Dentistry" are adherents of their college and are informed about the mission of the organization from the website, information boards and communication with teachers. All students are aware of the qualification requirements of the specialty from the first lesson and strive to achieve the final learning outcomes on the programme. There are no unsuccessful students in this specialty.

- 2) implemented international quality management system;
- 3) developed Strategic plan with the main directions of educational activities of the college;
- 4) broad representation in the adoption of the plan by college educators and consumers the educational process of practical health care, students, parents, transparency-based and publicly available academic policy of the college;
- 5) active and mutually beneficial integration with practical Health care;
- 6) various types of learning outcomes.

EEC received convincing data on the methodological support of the educational programme, the use of various teaching methods (traditional and interactive) by teachers. When questioning students, a high percentage of student satisfaction with college education was found. Students of the specialty "Orthopedic Dentistry" participate in exploratory work and speak at conferences. The work of the Volunteer Movement "Healthy Teeth, Healthy Children, Healthy Family"

#### **Strengths:**

Thus, all 9 accreditation standards have been met, no inconsistencies in the fulfillment of the criteria of each of the basic accreditation standards in the process of analyzing the self-assessment report and conducting the examination as part of the tasks of the external expert evaluation programme were found.

# 5. Recommendations for improving the educational specialty 0307000 - "Orthopedic dentistry" qualification 0307013 - "Dental technician" ":

- 1. To continue updating the material and technical base of the college.
- 2 Supplement the college library fund with modern educational literature and electronic educational publications.
- 3. Expand the catalog of elective disciplines, taking into account the needs of practical health care.
- 4. To develop regulations on the choice of elective disciplines in the specialty.
- 5 Strengthen and expand international cooperation in the field of dentistry.
- 6 To wider involve students and employers in the development of EP.
- 7 Introduce dual training according to EP.

#### 6. Recommendation to the ECAQA Accreditation Council

According to the results of the expert evaluation of the educational programme in the specialty 0307000 "**Orthopedic dentistry**" qualification 0307013 "**Dental technician**" of the State Enterprise on the REM "Pavlodar Higher Medical College" of the Department of Health of the Pavlodar region for compliance with the accreditation Standards of the organization of educational programmes in medical and pharmaceutical specialties of technical and vocational education, the members of the EEC came to a unanimous opinion to recommend the ECAQA Accreditation Council to accredit the above-mentioned educational programme for a period of 5 years.
