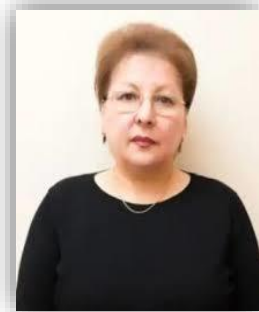

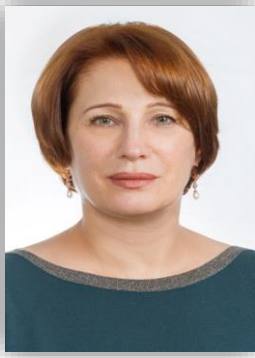

The work of the EEC was carried out in accordance with the Regulation on the EEC (Order of the ECAQA General Director No. 4 dated February 13, 2017).

The EEC report contains an assessment of the educational program in the specialty 0304000 "Dentistry" 0304013 "Dental Assistant" of the Kostanay Higher Medical College of the Health Department of the Kostanay Akimat for compliance with the ECAQA Accreditation Standards, recommendations of the EEC on further improving the training programs.

**2. General part of the final report of the EEC**

**2.1 Representation of the PSE "Kostanay Higher Medical College" of the Health Department of the Akimat of Kostanay region**

Kostanay Medical College was opened in 1929 as an obstetric technical school, in 1996 the Kostanay Medical School received the status of a college.

In April 2018, the College received the status of a higher medical college (Resolution No. 307 of June 29, 2018). Brief information about the college is available on the website [www.vipusknik.kz](http://www.vipusknik.kz) On the page <https://vipusknik.kz/institutions/college/kostanayskiy-meditsinskiy-kolledzh>

The college carries out educational activities on the basis of state license No. KZ90LAA00012840 dated 12.09.2018 from specialty 0304000 "Dentistry", qualification 0304013 "Assistant to a dentist".

The number of personnel trained for health care over 5 years is 11066, including those trained on the budget - 669 people.

The college is located in a typical building, the total area of all premises used for organizing the educational process is 3712 sq. m., Calculated per one teacher is 4.3 sq. m.

## **2.2 Information on previous accreditation**

Specialized accreditation of educational programme 0304000 "Dentistry" 0304013 "Dental Assistant", certificate for 5 years, (SA No. 0030 dated June 19, 2017 "Independent Agency for Quality Assurance in Higher Education" (IAQAHE) Post-accreditation monitoring - July 2019.

## **2.3 Analysis of self-assessment reports for specialty 0304000 "Dentistry" qualification 0304023 "Dentist", qualification 030413 "Dental Assistant" for compliance with the Accreditation Standards**

Report on self-assessment of educational programmes in the specialty 0304000 "Dentistry", qualification 030413 "Dental Assistant" on 109 pages, of which 14 pages are applications.

The report is characterized by the completeness of responses to all 9 accreditation standards, structuredness based on the recommendations of the ECAQA Self-Assessment Guidelines, and the internal consistency of information provided by the accredited college. The report is written voluminously, competently, the sequence and logic in the description of the standards is observed, the wording for each standard is clear and understandable, the tables contain references in the text and are numbered continuously. There are links to regulations, model rules, regulations, educational documents, website pages <http://www.komeco.kz/> The reports are accompanied by a cover letter signed by the director Ospanova Aigerim Kairovna, Ph.D., confirming the accuracy of the information and data contained in the reports.

The report contains a list of 19 members of the internal self-assessment commission, indicating the responsibility of each employee, information about the representative of the organization responsible for the institutional and specialized (programme) self-assessment - Zharmatova Ainagul Altynbaevna - Deputy Director for Academic Affairs. The chairman of the working group for the preparation of accreditation is A.A. Zharmatova.

Institutional and specialized self-assessment of the PSE "Kostanay Higher Medical College" of the Health Department of the Akimat of the Kostanay region was carried out on the basis of order No. 50-P dated 12.02.2020. "On the appointment of those responsible for the preparation of the self-assessment report within the framework of institutional and specialized accreditation."

## **2.4 General assessment of the educational programme of the specialty 0304000 "Dentistry", qualification 030413 "Dental Assistant" for compliance with Accreditation Standards**

For this specialty, the form of training is daytime. The normative term of study for the qualification "Dental Assistant" is 1 year 10 months on the basis of general secondary education. In

total, during the period of implementation of the educational programme "Dental Assistant", 24 people were trained.

In training in this specialty, 21 teachers participate, including 8 people with more than 10 years of experience, 2 masters, 3 excellence in healthcare.

The report contains the actual practice of the organization for the training of specialists in the specialty "Dentistry", qualifications 0304013 "Assistant to a dentist" and 0304023 "Dentist" reasoned data, examples of the implementation of educational programmes, national and international events, methodological support of the educational programme, confirming compliance with the requirements of accreditation standards ...

### 3. Description of external peer review

External expert work on institutional accreditation and evaluation of educational programmes of the PSE on the REM "Kostanay Higher Medical College" (hereinafter referred to as the college) of the Health Department of the Akimat of the Kostanay region on the specialty 0304000 "Dentistry" qualification 030413 "Dental Assistant" (1 year 10 months) was organized in accordance with the Guidelines for conducting an external assessment of educational organizations and educational programmes of ECAQA (approved by order of the Director General of the NU "Eurasian Centre for Accreditation and Quality Assurance in Higher Education and Healthcare" No. 15 dated September 11, 2020) and according to the programme and schedule approved on September 25 2020 Director General of ECAQA Sarsenbayeva S.S. and agreed with the director of the candidate of medical sciences Ospanova A.K.

To obtain objective information, the members of the EEC used the following methods: interviews with management and administrative staff, interviews with students, observation, study of the website, interviewing employees of various structural units, teachers, online questioning of teachers and students in the period 6-12.10. 2020, a review of resources in the context of the implementation of standards for institutional and specialized accreditation, the study of college documents and teaching materials for 8 accredited educational programmes.

On the part of the college staff, the presence of all persons indicated in the visit programme and according to the lists of interviews, interviews and demonstration of practical training in accordance with the requirements of the sanitary doctor of the region in a pandemic was ensured (Table 1).

The experts individually filled out quality profiles and external assessment criteria (institutional and for each educational programme) for the appropriate complying with ECAQA accreditation standards. Recommendations for improvement were discussed, draft reports were prepared (9) and recommendations for improving implementation for each educational programme separately. The Chair conducted a final open vote on college recommendations and a final vote on recommendations for the ECAQA Accreditation Council. Then the chairman of the EEC for the management and

employees of the educational organization announced recommendations based on the results of an external assessment in the framework of institutional accreditation and accreditation of college educational programmes.

#### **4. Results of the survey**

The ECAQA observer conducted an online survey of college students on the resource <https://webanketa.com/> from 6-12.10.2020. In total, the proposed questionnaire contains 22 questions, including an assessment of satisfaction with training and organization resources. The total number of students to whom the questionnaire was sent is 1179. The total number of respondents is 604.

By specialties: "Nursing" qualification "Paramedic" - 72%, "Nursing" qualification "Midwife" - 4%, "Hygiene and Epidemiology" - 0.16%, "General Medicine" - 11%, "Laboratory diagnostics" - 3%, "Dentistry" - 7%, "Orthopedic Dentistry" - 0.33%, "Pharmacy" - 1%, "Medical Optics" - 0.33%.

**Conclusion:** The external expert commission of ECAQA determined that the college has a corporate culture and ethical behaviour between all participants in the educational process, as well as a developed system of mentoring and consulting students on academic and personal issues. This leads to a positive attitude of students to the place of study. At the same time, students are not fully involved in the work of advisory bodies on the development of the mission, discussion of the educational programme and the educational process. Low involvement of students in research work, including in dentistry, was noted. Not all teachers provide feedback on the results of the lesson, and teaching methods need to be improved.

**An online survey of 78 teachers was carried out on October 6-12, 2020, the number of respondents was 58 (according to the staffing table - 78).**

Pedagogical experience up to 5 years - 48.24%, from 5 to 10 years - 12.06%, over 10 years - 40%.

**Findings:** the team has a corporate spirit and support from the management. The teachers are satisfied with the working conditions and the organization of the educational process, at the same time, it is necessary to complete special disciplines with qualified teachers, to strengthen the issues of advanced training in subjects and in the QMS.

#### **5. Analysis of compliance with accreditation standards based on the results of external assessment of educational programmes in the specialty 0304000 "Dentistry", qualification 030413 "Dental Assistant" and review of strengths for each standard.**

##### **Standard 1: MISSION AND OUTCOMES**

###### **Strengths identified:**

- formation of students' practical skills, taking into account the real needs of health care development;
- active use of information and innovative pedagogical technologies and principles of a scientific approach that develop students' communication skills, analytical and critical thinking;
- the presence of simulation rooms and a dental laboratory for the development and formation of professional competencies on modern devices, simulators and phantoms;
- educational components included in the training process are aimed at instilling national values, the formation of patriotism and citizenship, the development of versatile interests and abilities in students, and the formation of a healthy lifestyle.

***Recommendations for improvement identified during the external visit:***

1. To develop a Regulation on elective disciplines, defining the order of their choice, conditions and procedure for organizing the educational process in elective disciplines;
2. Coordinate the topics and content of elective disciplines in the specialty "Dentistry" in accordance with the needs of practical healthcare;
3. Strengthen the formation of communicative competence, critical thinking and decision-making skills among students of the specialty "Dentistry";
4. To improve the mechanism of student participation in the development and improvement of educational programmes and catalogues of elective disciplines;
5. To update the contracts for professional practice for the organization of TVE and post-secondary education and bring them in line with the requirements of Order No. 93 of 28.01.2016 of the Ministry of Education and Science of the Republic of Kazakhstan;
6. Introduce a dual training format for the specialty "Dentistry".

**Standard 3: ASSESSMENT OF STUDENTS**

**The strengths of the college have been identified and include:**

- students are assessed using sequential procedures based on common criteria and provisions;
- unified automated control system of students' knowledge;
- satisfaction of participants in educational activities with the quality of educational services;
- a high percentage of progress when passing the final certification;
- monitoring the level of professional readiness of students at various levels of the educational process;
- high rates of demand and employment of college graduates.

***Recommendations for improvement identified during the external visit:***

1. To develop a procedure for assessing the reliability and validity of the methods used to control the knowledge of students specializing in "Dentistry".

**Standard 4: STUDENTS**

**The strengths of KRHMC have been identified, which include:**

- college admission policies and criteria are objective, transparent and transparent;
- sufficient level of students' training, corresponding to the requirements of the health care system;
- conditions for the realization of the creative potential and personal growth of students;



- stable results of academic performance and quality of knowledge of students;
- the demand for graduates for practical health care;
- the presence in the college of a self-government system for students, a system of social support for students;
- efficient student support service.

***Standard 4: completed***

***Recommendations for improvement identified during the external visit:***

1. To increase the percentage of students' coverage of research work;
2. To ensure the formation of competencies in the preparation and conduct of scientific research by students.

- availability of qualified staff of teachers;
- an effective system of material and moral incentives for the work of teachers and staff through rating score;

- advanced training of teachers and college staff in regional, republican, international courses and seminars;

***Recommendations for improvement identified during the external visit:***

1. To intensify the publishing activities of teachers;
2. Continue staffing with qualified personnel in special disciplines of the specialty "Dentistry";
3. To include in the system of continuous professional development of college teachers, training courses aimed at developing the competencies of research work, as well as establishing and maintaining international scientific contacts;
4. Provide professional development of teachers for at least 108 hours within 5 years in the relevant profile on the basis of order No. 391 of the Ministry of Education and Science of the Republic of Kazakhstan.

### **Strengths identified:**

- a good material and technical base corresponding to the State Educational Standard of Education and SanPiN, which is constantly updated taking into account the needs of practical health care;
- availability and constant replenishment of the park of modern simulation mannequins, computer and interactive equipment;
- high assortment and selection of material and technical, information, library resources;
- the presence of an electronic library system;

***Recommendations for improvement identified during the external visit:***

1. Renew the library fund for the specialty dentistry;
2. To activate the work of AIS "Platon" on filling in the data of teachers and students, library data, teaching materials by discipline;
3. Develop and implement a policy of international cooperation aimed at improving the planning and implementation of international activities in priority areas;

**Standard 9: CONTINUOUS RENEWAL**

In the college has all the necessary modern educational material and information resources to provide high-quality professional education for students. For college students, conditions have been created for research work, active creative work and an interesting eventful student life.

The teaching staff of the college, on the basis of a competence-based approach, introducing and effectively using modern educational technologies, is focused on the continuous improvement of the quality of education, and the college administration provides all the conditions for improving the qualifications and growth of the professional level of teachers.

At the beginning of 2021, the operation of a student hostel for 250 places is expected.

The college continuously improves the quality of educational services provided.

**Strengths identified:**

- planned training of teaching staff and AUP abroad and within the country.

**EEC conclusions by criteria. Out of 4 standards conform: fully-3, significantly - 1, partially - 0, do not correspond - 0.**
